

AUTHORIZATION U18 and U16

Therefore, I hereby exempt Euroleague Ventures SA from any liability for any type of use that may be made by a third party, contrary to or different from the terms set out in this section.

As consideration for being the Participant permitted by the Organizer to participate in the Event, **I forever release the Organizer, and their respective directors, officers, employees, volunteers, agents, contractors, and representatives (collectively "Releasees") from any and all actions, claims, or demands that I, my assignees, heirs, distributes, guardians, next of kin, spouse and legal representatives now have, or may have in the future, for injury, death, or property damage, related to (i) my participation in these activities, (ii) the negligence or other acts, whether directly connected to these activities or not, and however caused, by any Releasee, or (iii) the condition of the premises where these activities occur, whether or not I am then participating in the activities.** I also agree that I, my assignees, heirs, distributes, guardians, next of kin, spouse and legal representatives will not make a claim against, sue, or attach the property of any Releasee in connection with any of the matters covered by the foregoing release.

I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN MYSELF AND THE ORGANIZER, AND SIGN IT OF MY OWN FREE WILL AND ALSO VERIFY THAT THE DANGERS OF THE EVENT AND THE SIGNIFICANCE OF THIS AUTHORIZATION WERE EXPLAINED TO THE PARTICIPANT AND WE (I AND THE PARTICIPANT) UNDERSTOOD THEM.

There shall be no benefit or remuneration of any kind for the licenses for the Authorization granted under this document.
